FINAL PROVISIONS

In addition to the fees from the Decision on fees in business with consumers, the Bank may also calculate and collect from clients the fees of FINA, the CNB, the Money Market as well as other entities, depending on a specific service and its realization.

In addition to the fees and individual services, the Bank may also calculate the actual costs, such as:

- postage and telecommunications costs
- costs charged by other banks in the country and abroad
- fees, taxes and similar paid by the Bank
- other costs that are not specified, but are determined by the Agreement between the Bank and the user of the service.

Fees are variable and they are calculated and charged according to the valid Decision on Fees in Business with Consumers.

During the contractual relationship, the Bank will not charge the client a fee that was not contained in the Decision on fees in business with consumers at the time the Agreement was concluded.

The fees listed under Item 18.7. to 18.21. will be calculated and charged only for the loans contracted after 1 June 2015.

The fees listed under item 18.03. to 18.5. will be calculated and charged only for the loans contracted after 15 December 2019.

A non-consumer is a natural person with the activity within the scope of his or her economic activity or a freelance profession.

The decision on fees is an integral part of the framework agreement.

Depending on its business interest, business significance, market conditions, the Bank's Management Board may determine a different amount of the fee than the fee specified in this Decision.

This Decision enters into force and applies from 1 January 2023.
